## 2.1 - Additional WASBA race sponsorship opportunities

J Diederich noted that Pinjarra agreed to retain the King-Lethbridge at \$14,000 without WASBA's stakes contribution.

J Diederich noted that all previous WASBA submissions for incentives/initiatives need to be revisited given the new RWWA management. While communication from other states concerning initiatives was freely provided, this was not the case with RWWA.

#### 2.2 - 2024 WASBA Country Oaks

J Diederich referred to the previous Minutes and noted that attempts will continue to be

made in discussions with the RWWA office to obtain the best timing for this race.

J Diederich discussed the level of prizemoney for the Country Oaks and similar \$30,000 races restricted to 2yos or 3yos, noting that Westsired winners were financially better off with stakes lower than \$22,000 due to the Bonus payments for those races.

Committee **agreed** that WASBA could consider Epona type credits rather than stakes reduction, for any races where WASBA considers this appropriate.

#### 2.3 – WASBA Bob Humphries Memorial (Bunbury 15 November 2023)

J Diederich attended the Bob Humphries meeting along with member D Trobe. The Bunbury Club was very helpful in ensuring the necessary arrangements for the presentation were made. Thanks to Chris Voak who assisted with the rugging and parade of the winner, ensuring trainer driver Madeliene Young could attend the presentation on behalf of the owners.

## 3 Standing Item - Fillies and Mares Racing

J Diederich noted that the new HRA Group racing policy had diminished nearly all the previous Group and Listed races for fillies in particular and some of the special mares races including the Breeders Stakes. Some of these races are at risk of being further diminished without having the status, and additional funding is unlikely.

## 6 Reports

## 6.1 HRCG Meeting (15 November 2023)

J Diederich referred to the draft minutes that had been circulated to the Committee.

H King noted that RWWA had reported decreased turnover and revenue, and Revenue as a proportion of stakes has decreased. H King also referred to the review into online gambling with a likely impact across the industry

H King referred to an independent review that has been submitted to the RWWA Board around RWWA's strategic approach now that the TAB is being retained.

The review of cambers is being wrapped in a general overview of positioning of harness.

J Diederich noted RWWA's name change to Racing WA.

#### 7 General Business

#### 7.1 APG Sales Classic Night

J Diederich reported that APG have been slow to respond to our requests regarding the APG/WASBA awards night, as well as our request for sponsorship. WASBA's provision of rugs and garlands is conditional on the sponsorship being agreed to. J Diederich has advised APG that WASBA would not undertake the awards night without the co-sponsorship.

In the interim J Diederich reported that liaison had occurred with Gannons reference the rugs and TheTrotsWA reference any invited guests should the event go ahead.

## 7.2 Busselton Sweetheart Series

J Diederich referred to communication from Busselton and confirming that, subject to Committee agreeing, WASBA would provide the same sponsorship as for the Busselton Sweetheart Season in the 2022/23 season, which was \$500 to the leading point scoring Westbred mare, \$500 to the racebook owner of the leading point scoring Westbred mare, and \$500 in a random draw for Westbred runners in the Sweetheart Series, with one entry per start.

**Moved** J Fletcher and **Seconded** P Borg that \$1500 in sponsorship for the Busselton Sweetheart Series be provided under the same conditions as the 2022/23 Busselton Sweetheart season (**Carried**).

## 7.3 WASBA Awards – Preliminary Selections

J Diederich referred to material forwarded with the Agenda to determine interim age category award winners based on a points based system, adapting HRA Group race outcomes and dollars earned. Other awards require the full year to be completed before any assessment. J Diederich advised that some of the awards were more clear cut than others and Committee could change the preliminary result once the final statistics are available in January.

J Diederich referred specifically to the Golden Nugget and the winner potentially impacting two of the results. If the winner was Westbred it would also mean that there were 3 open Group 1 winning Westbreds that would be eligible for a trophy and \$500 service fee voucher, provided their membership was current and they were represented at the award function.

Following discussion, the preliminary award winners in the aged categories were:

- 2YO colt/gelding Menemsha (Group 1 Westbred Classic and Pearl Classic)
- 3YO colt/gelding Never Ending (Westbred Classic and Pearl Classic)
- 4YO and over horse/gelding Mighty Ronaldo (Group 1 Fremantle Cup)
- 3YO Filly August Moon (Group 1 WA Oaks)
- Mare Wonderful To Fly, unless another Westbred mare won the Golden Nugget.

As the winner of the Fremantle Cup, Committee did not at this stage consider that the winner of the Golden Nugget, if male, would warrant a change to the award for 4YO and over male

Committee was divided on the outcome of the 2YO Filly of the Year with leading point scorer Water Lou and leading earner Xceptional Arma being in contention.

Final decisions for these and all awards will be made at the January Committee meeting.

## 7.4 Sponsor Appreciation

J Diederich referred to the Christmas cards purchased earlier in the year to forward to WASBA sponsors to thank them for their support. J Diederich referred to Committee agreement at the September meeting to forward an email thanking them for provision of a stallion service and asking them to consider preferencing organisations assisting breeding activities, over clubs seeking funds for general revenue.

## 8 Next Meeting
