2 Confirmation of Minutes

3 Business Arising from the Minutes

1 Standing Item - Membership

2.1 – Additional WASBA race sponsorship opportunities

J Diederich reported that the February meeting arranged with Harness Manager Special Projects Cameron Brown had been positive, enabling WASBA to discuss the WASBA sponsored races at Narrogin and Albany. C Brown put forward that no additional funding is available from RWWA at this point. WASBA will therefore need to target the existing \$11,000 races allocated to these clubs to supplement to \$14,000.

J Diederich reported on the successful Busselton meetings and the Sweetheart Series, noting the deadheat for the leading point scoring Westbred mare. There were no WASBA conditions in that circumstance. Both leading point scorers Motor On Lilly and Cheap Thrillz were awarded the WASBA sponsorship. Random draw winner was Miss Laurel Lee.

Representatives of the winners were presented with their \$500 Service fee Vouchers on the night. Emails have been forwarded advising how to claim their \$500 in winnings.
