WASBA Committee Meeting Wednesday 24 April 2024 By teleconference

2 Confirmation of Minutes

Moved J Schaper **Seconded** M Holtham that the minutes of the meeting held 27 March 2024, having been previously circulated to members of the Committee, are accepted **(Carried)**.

3 Business Arising from the Minutes

1 Standing Item - Membership

2 Standing Item – Industry Sponsorship

2.1 - Additional WASBA race sponsorship opportunities

J Diederich reported that little progress had been made. Narrogin is aware that advice is required before the end of April to enable timely ordering of presentation items for June.

There has also been little progress with Albany, but this is less time sensitive due to their racing season being December to February with December being the target month.

WASBA will be providing \$3,000 towards stakes for each of the two races, as well as the rug, trophy and garland.

2.3 – Race For Roses (5 April 2024)

J Diederich noted that it will be necessary in the future for the driver to be available for a parade with the horse, outside of exceptional circumstances, if a rug and/or garland is being provided. WASBA will retain the garland for later use if the parade does not occur.

2.4 - WASBA King-Lethbridge at Pinjarra (22 April)

J Diederich reported that the support from the Pinjarra Club through Dale Putland and Barry Warwick was brilliant, including their participation in the awarding of Life Membership to Ed Dewar. Ed Dewar was very appreciative of the award and the invitation

2.5 - WASBA Breeders Stakes (3 May 2024)

J Diederich reported that all sponsors have been contacted. One sponsor declined.

J Diederich has requested a hospitality package from Gloucester Park in Steelos, due to the success of the occasion last year. A response is expected soon... **Action: J Diederich**

2.6 – 2024 Harry Capararo 4YO/5YO Westbred Mares (10 May 2024)

J Diederich reported that Peter Capararo has sent his apologies as the family will be overseas at the time. A trophy will be presented on track.

2.8 - \$30,000 Country Oaks

J Diederich reported that the changes agreed with Harness Manager Special Projects C Brown will not go ahead as it is apparent that those agreed changes – a golden ticket and a race date two weeks before the WA Oaks – had not been communicated to staff before the feature race program for August to December was released. C Brown subsequently advised that it was not possible to make those changes this year. J Diederich advised that WASBA will still seek a golden ticket for the 2024 Country Oaks winner, and a commitment to a change of date for 2025.

4 Standing Item – Liaison with RWWA

4.1 – Breeding Initiatives (Epona Proposal, HRA Breeding Report Initiatives, Other State/NZ Initiatives, Westbred Bonus Scheme)

J Diederich referred to:

- initiatives in other jurisdictions (US, NZ, other States) to provide improved opportunities for the older and lower level horses,
- race distances for 2yos to be restricted in the early part of the year
- timing of features particularly for juveniles and an extended race program for juveniles
- field sizes
- · free returns outside the stallion cap
- extended race
- Options for First Win Breeder Bonus (a choice of possibly \$1500 or a Service Fee Voucher as an alternative to waiting for the \$3000)
- A proposed drop back rule was no longer relevant, with the announcement that the HWOE system will be abandoned.

6.1 HRCG Report

H King noted the change to the HRCG cycle which is now bi-annual to match the RWWA Board funding cycle. As a result the Eligible Bodies should meet directly with the relevant RWWA staff. Should a full HRCG meeting be considered necessary, RWWA will arrange it.

7 General Business

7.1 Changes to WA Handicapping System

J Diederich emphasised the need for people to contribute when the opportunity is presented. WASBA must be pro-active in pushing for components of the system that are advantageous to WA bred horses in particular. This includes maiden races and juvenile races that enable owners to earn bonuses.

H King noted that the most important component of the system is the race program.

J Diederich requested Committee members put forward any ideas regarding how the national rating system could be successfully applied in WA.
