- Research in the eastern states concluded that a major reason for abortion in mares was due to mares ingesting hairs of the hairy caterpillar embedded in grass;
- Horses failing yearling sale scopes were as likely to do well as others, as juveniles.
- The Ag Department will test aborted foals for free, by arrangement with breeders
- Money from each stallion breeding and mare service in thoroughbreds goes forward to research, as well as government and industry financial backing.

7 General Business

7.1 Harness Racing in Victoria

J Coffey provided a summary of the financial situation in Victoria and the industry meeting held to discuss the issues facing Victoria

The meeting arranged by the Kindred Bodies was heavily attended with participants travelling long distances to attend.

The situation in Victoria is dire and may result in land being held for the future of harness racing being ceded to the government, including the Melton track itself.

Significant losses have occurred over the last 5 years.

It is unsure what the next steps are to recover the situation.

There will be a follow up meeting to discuss the failures of the National Rating System and how to address that issue

Victoria will withdraw funding from Eureka

All participants were encouraged to lobby their local members of parliament.
